**Jammin' Foods Fest:** Food truck event with live music, beer/wine garden and retail vendors. Limited number of vendors for this event

**Attendance average:** 600    **Vendor Fee:** \$50    **Location:** New Market Community Park

**Deadline:** May 1st, 2026

**Fall Festival:** annual craft vendor event with live music, food, and activities. No more than 4 food vendors. *(not including snack foods such as cotton candy or kettle corn)- Note: The majority of vendors will be set up along the street in parking spaces facing toward the sidewalk. Route 11 (Congress Street) is not closed to through traffic during the event.*

**Average attendance:** 300+    **Vendor Fee:** \$50    **Location:** Downtown New Market (Congress St.)

**Deadline:** September 4th, 2026

### Important Vendor Information

- Vendors agree to be open and ready by event start time, unless other arrangements are agreed upon by Event Coordinator.
- Direct Sale businesses must have cash and carry items.
- Vendors are to be in compliance with all Health Department Regulations & obtain required permits for Shenandoah County (as needed)
- No refunds of vendor fee, unless the festival is canceled by Event Coordinator due to weather conditions.
- Vendors are responsible for their site clean-up. Trash truck will be on-site and the Town will handle proper disposal of waste.
- Electricity is not provided, unless arrangements are made with the Event Coordinator
- Specific details about event such as venue address, set up times, etc. will be emailed prior to the event.
