### **MAYOR'S CORNER**

That is the date and time for us, the Town of New Market, to accept the deed transfer from the American Legion Post 166 and the New Market Community Center (NMCC) Board. The event will be held in the gymnasium of the NMCC. We want to publicly thank both of these organizations for giving the citizens of New Market such gifts of their valuable properties. I ask you to attend this ceremony and help us show our appreciation to the members of the Post and the Board.

Immediately following the ceremony, we will have an open house so that you can tour the community center in its present state. I am sure that many of you that attended school in this building will have many fond memories to share with one another. The tour of the facility is to also encourage ideas for the future use of the property. The Town Council has established a steering committee to gather these ideas and establish goals for the near and long term use of the Center. The steering committee will work hand in hand with the council and town to decide what is financially feasible AND sustainable. We can dream it, but can we afford it?

## HASSLER-SUTPHIN POST 166 P.O. BOX 166 NEW MARKET, VA 22844

As you have most likely heard by now, the American Legion Post 166 voted to donate the American Legion building and grounds to the Town of New Market. The supporting members, whose ages are averaging 80 years, were unable to keep up the monthly expenses such as, insurance, taxes, dumpster fee, and utilities.

Only a few members were doing all of the fund raising projects. These fundraisers, chicken bar-b-q, craft show, yard sales, apple butter boiling, and Friday night dinner specials in the Club Room were to support Boys State, Legion Baseball and other Legion projects; as well as provide for veterans stopping by in need of some fuel and/or a good meal. Food was collected and donated to area food banks and from time to time the banquet room was rented for special occasions. Legion members also visited Martinsburg VA hospital 4 times a year for many years.

In order for Post 166 to keep its charter, we need some dedicated veterans to volunteer to become the following officers: Commander, Vice-Commander, Adjutant, Finance Officer, and Chaplain, so the Legion programs can continue.

A sizable portion for funding the community center's improvements will come from the proceeds from the sale of the Legion's property. As a lasting memorial to Post #166 we will name a portion of the center in their honor. Every person who steps foot in the designated area will remember these soldiers and their families that sacrificed of themselves so that we, the citizens, can enjoy our freedom and liberties. The carnage that has engulfed Ukraine should remind us that freedom is not guaranteed.

In addition to funds from the sale of the Legion property, we are pursuing grants that are available from private and government programs. We will also work with local businesses, churches and social organizations to assist in the remodeling of the building and program development. Although the Community Center's future is exciting, please be patient as we chart its course. Engineering, fund raising and construction takes time and, for us, that starts at 10:00 am, April 23, 2022. Come join us for the ceremony and open house.

# HEAVY TRASH PICK-UP

The Town's Public Works Crews will be collecting heavy trash items from April 11th through April 15th, 2022. Please place all heavy trash curbside. Crews will not go onto private property to make collections. This service is provided to our residential customers only. Crews will pick up trash by item type during the week and will have all trash picked up by the end of the day on Friday, April 15th, 2022. Brush and limbs must be tied in bundles no longer than four feet in length. To ensure removal, all heavy trash should be placed curbside no later than Friday, April 15th, 2022 by 12:00 noon. Due to State laws governing the operation of the Shenandoah County Landfill, the Town is unable to remove old TVs, computers, tires, refrigerators, freezers, lead acid batteries, or hazardous materials such as pesticides, herbicides, paint, paint thinner, etc. For instruction on where to take the aforementioned items, you may call the Shenandoah County Landfill at 540-984-8573. Thank you for your cooperation.

Just a reminder that dogs are to be kept on a leash at all times when walking along public streets and in the park. Dogs are not allowed on the baseball fields or tennis courts.

#### PET WASTE

Pet waste left on the street or lawn does not just go away or fertilize the grass. Rain washes pet waste down storm drains and into waterways like rivers, bays, and beaches. Pet waste also provides a nitrogen source for algae blooms, which deplete the water of oxygen and can make people and animals sick.

The Town of New Market has an ordinance regarding pet waste. Sec. 14-3.1 – Unlawful to allow dogs to defecate on public or private property; exception

a) No person shall knowingly or willfully allow a dog belonging to him or in his custody to defecate on the private property of other persons without the consent of such persons, or to defecate on public property; except that defecation by a dog on such property shall not constitute a violation of this section if the owner or person in custody of the dog immediately removes the material defecated and disposes of it in a safe and sanitary manner.

b) Any person violating and foregoing provisions of this section shall be guilty of a class 4 misdemeanor for each violation.

#### What You Should Do

• Keep a supply of bags handy

When walking your pet, take a bag with you for quick waste pick-up. It helps to keep a supply of bags near your dog leash and to tie the bags on the leash if you don't have a pocket or pack. Consider re-using plastic newspaper bags or bread bags. Use the bag to pick up the waste, and tie it closed. When at home, long-handled pooper-scoopers, available at pet stores, make it easy to pick up after pets without stooping over.

• Dispose of pet waste properly

Place sealed bags of pet waste in the trash. It may help to double bag dog waste or kitty litter. Do not throw waste near or into storm drains, and do not dump kitty litter outside. Do not flush pet waste down your toilet.

• Follow local rules and signs

Some cities and towns have fines for not picking up waste on streets, in parks, or in dog parks.

• Help others remember to scoop the poop

Don't let your pet pollute, and encourage those around you to be responsible pet owners, too.

## SHORT-TERM RENTALS INCLUDING AIRBNB

The Town of New Market has passed Ordinance No. 107 which amends certain provisions of the Town Code relating to Short-Term Rentals. Operators of short-term rentals must obtain a zoning permit, an annual business license, and collect and remit to the Town a 5% transient occupancy tax.
