MAYOR'S CORNER

The Town of New Market had its first and second significant snowfalls in January. My first concern was to check and see if I needed to shovel my property, and second, to see if the roads were cleared. Well, the roads were clear and treated but I still had to shovel! The Town's crews did a great job from my viewpoint! (My driveway took a little while.) So, a special thanks to our maintenance crew members for clearing the roads so quickly.

I am hoping to use the Town's newsletter to communicate areas of short-term importance as well as longer term expectations for our residents. In the last newsletter I highlighted the major projects we have planned. I want to use this issue of the newsletter to manage some expectations. Based on the condition of the current water tank, the new water tanks are absolutely needed in order to provide a reliable water supply. The costs are being finalized, and the financing will require the Town to take out a note to cover the costs. There are two tanks that are going to replace the current tank. The height of the tank on the hill is needed to provide water pressure. The reason for a second tank is the need for "redundancy," which means that in the event of a problem the Town will have an alternate source of water. Currently we do not have this insurance available. This project will be costly, but we have to ensure that our residents and businesses have a reliable water system. As the final costs are calculated we know that the costs will need to be reflected in water/sewer bills. In the coming months residents will be provided with more specific information once we are able to finalize more details and costs.

Water is a commodity, and the cost is determined by how much water is used. If you are thinking about how to manage your costs for water, it may be useful to consider your home's current uses of water and to consider some ways to reduce water usage. Knowing that there are new water rates coming to cover the cost of the tanks, I have been looking at water conservation practices and strategizing how to reduce water use in my home and stay under the minimum usage. There are many resources available to get good information on how to reduce the use of water. The September 2024 issue of *Consumer Reports* has an overview that is a good place to start looking for water conservation suggestions. The New Market Library has this copy of Consumer Reports available for you to read and learn more about this topic.

Lastly, in today's newsletter I would like to establish a time when I can be available to meet with residents to discuss topics about the Town, current projects, or consider suggestions that any resident might have. I will be available on Town Council nights, typically held on the third Monday of the month, at 6:00 P.M. to meet briefly, or set up a longer meeting, if needed. WINTER WEATHER ADVISORIES

The onset of the Holidays often brings cold weather and snow right along with it. Whether the storm totals 1" or 12"+, winter weather presents challenges for all of us. Here are a few tips in advance of this winter season:

- **Be prepared:** Predicting weather seems to be a challenge even with advances in 21st century meteorology. With few exceptions winter storms are rarely a total surprise. Winter weather advisories are usually posted days in advance of the storm. Use that time to restock your medications, food and other essentials.
- **Be careful:** It may seem like an overused piece of advice, but when you travel unnecessarily on snow covered roads you put yourself and your vehicle at risk and make clearing roads that much more challenging. For those of you who do have to travel, plan ahead and leave yourself extra time to get to your destination.
- **Be patient:** Removing snow from streets takes time. Storm duration, temperature and sunlight all affect how quickly streets are cleared. Often it's not until the sun returns and day time temperatures exceed 32 degrees that frozen snow and ice on streets can completely be removed.
- **Be helpful:** After the snow has stopped, please help keep your neighbors and friends safe by clearing the sidewalk(s) that fronts your property. It's not only the right thing to do; it's also required by town ordinance.



NEW MARKET FIRE AND RESCUE NEWS

Winter is here. We hope that everyone is staying warm. With the winter months here and the snow falling, we would like to remind everyone of the following:

- 1. If you use heaters in your house, please make sure that you keep everything away from the heater.
- 2. Please help us if you have a fire hydrant near you by keeping it clean so that if we need to use the hydrant it will be easily accessible.
- 3. If we are experiencing bad weather, you only go out when necessary. We want to make sure that your safety is taken care of.

For 2024, Our crews ran a total of 1644 calls for the year. Of those calls, 1156 were for EMS services and 113 for Fire Services and 774 of those calls were within town limits.

For December, our crews ran a total of 145 calls. Of those calls 97 were for EMS services and 14 were for Fire services with 72 of those calls within town limits.
