## MAYOR'S CORNER

Every year during the holidays I think about what a beautiful town we live in. As I write this, Christmas lights are lit along Congress Street, the New Market Community Park is lit up in the evenings, and many homes are decorated for the holidays. I thank those who helped with this and appreciate the work that our town employees have put into improving our decorations every year.

This is the time of year to be grateful and optimistic. I greatly appreciate the work done by Dr. Bompiani during his tenure as Mayor. Our town is in a better place because of his efforts! In addition, he provided a pattern and model on holding meetings and ensuring all points of view were presented. He will continue his service to New Market as an elected member of the Town Council.

Several years ago, we surveyed the residents of New Market to determine what improvements needed to be considered. As we enter 2025, many of the projects identified in the survey are being acted on. The good news is that the same council members who were elected as our projects were proposed and planned are still actively serving on the Council. It is to our advantage that Nathan Garrison, our Town Manager, is an experienced project manager and is now in a good position to help implement town improvements.

The new planning stage for the water tanks has required extensive reviews and this project has taken a great deal of time. We are now in the process of securing the financing. We should be set to begin the project by spring this year. As you have read in earlier information, our existing water tank needs to be replaced. The costs of this project will be substantial and necessitate increasing the cost of water/sewer for all residents and businesses. Please note that our water supply is good! But the infrastructure to provide the water to our town needs attention.

Most of the paperwork and planning is completed for a new sidewalk on Route 211 East. Sidewalks were the top priority on our town survey in 2017. It will increase the safety of our residents once this project is completed. Transforming New Market School into a Community Center will require more discussion and planning. Frazier Associates submitted a report on the scope and expense of the transformation as well as information on some possible grants to support this work. The Council will review and discuss this information as we start the new year. The Community Center will be an expensive project, so we will need to analyze the costs and benefits to consider how to contain costs and consider if we can find a sensible way to move forward.

As the new Mayor, I will be entering 2025 with a sense of energy and gratitude. I appreciate the support that our residents expressed in the election in November. I am grateful to continue working with the Council members who will serve our town over the coming years. The position of Mayor is a new role for me. I would like to find ways to increase public input and accessibility to the work we do on the Council. I hope to be able to hold informal meetings to hear feedback on various town issues. As I take stock of our Town's current situation, there are several store fronts downtown that remain empty. I hope we can work with property owners to analyze the condition and situation of these buildings to see how we can revitalize these properties. These properties are privately owned so our actions may be limited, but the impact of empty storefronts impacts the entire town. On a high note, a few new small businesses have arrived in recent months. This is encouraging! All New Market's businesses benefit from the support of our local residents.

## WINTER WEATHER ADVISORIES

The onset of the Holidays often brings cold weather and snow right along with it. Whether the storm totals 1" or 12"+, winter weather presents challenges for all of us. Here are a few tips in advance of this winter season:

- **Be prepared:** Predicting weather seems to be a challenge even with advances in 21st century meteorology. With few exceptions winter storms are rarely a total surprise. Winter weather advisories are usually posted days in advance of the storm. Use that time to restock your medications, food and other essentials.
- **Be careful:** It may seem like an overused piece of advice, but when you travel unnecessarily on snow covered roads you put yourself and your vehicle at risk and make clearing roads that much more challenging. For those of you who do have to travel, plan ahead and leave yourself extra time to get to your destination.
- **Be patient:** Removing snow from streets takes time. Storm duration, temperature and sunlight all affect how quickly streets are cleared. Often it's not until the sun returns and day time temperatures exceed 32 degrees that frozen snow and ice on streets can completely be removed.
- **Be helpful:** After the snow has stopped, please help keep your neighbors and friends safe by clearing the sidewalk(s) that fronts your property. It's not only the right thing to do; it's also required by town ordinance.

## **HEAVY TRASH PICK-UP 2025**

The Town's Public Works Crews will be collecting heavy trash items FOUR TIMES THIS YEAR (see dates below). This month, they will be out picking up your heavy trash items and live Christmas trees from Monday, January 6th through Friday, January 10th. Please place all heavy trash curbside. Crews will not go onto private property to make collections. This service is provided to our residential customers only. Crews will pick up trash by item type during the week and will have all trash picked up by the end of the day on Friday, January 10th, 2024. Brush and limbs must be tied in bundles no longer than four feet in length. To ensure removal, all heavy trash should be placed curbside no later than 7:00 am on Friday, January 10th, 2024. Due to State laws governing the operation of the Shenandoah County Landfill, the Town is unable to remove old TVs, computers, tires, or hazardous materials such as pesticides, herbicides, paint, paint thinner, etc. For instructions on where to take the aforementioned items, you may call the Shenandoah County Landfill at 540-984-8573. ## MAINTAIN ACCESS TO YOUR WATER METER

It is very important that customers maintain clear access to their water meters from the public right-of-way. Obstacles that may block the radio signals include building materials, foliage and metal objects located between the street and the meter pit.

All town water customers are responsible for the upkeep of the area between their meter pit and the street. Please assist us by trimming foliage and by clearing snow and ice from the lid of the meter pit. Landscaping or fencing should be kept at least 1-3 feet from the meter pit.

Maintain access to your water meter to assist us with:

- Meter Reading
- Emergency shutoffs (for frozen pipes) when you are away from home or are unable to turn off the water yourself; and
  - Emergency water meter maintenance
