## MAYOR'S CORNER

I open my discussion today with thanks and appreciation for the members on our town council. Six individuals that take time from their schedules and place New Market's needs above their own. On Saturday, March 12th we will be gathering together for 6 hours to prioritize goals for our town. This will be a morning that council members receive no additional financial compensation. Since I have been on council, our town manager has been able to schedule not one but two of these work sessions each year. By the way, it is not just the council's personal time but also the town's department heads that attend to give us guidance and answers to our questions.

You may question why is this "planning session" necessary? Well, as I mentioned in my last newsletter, we have accepted ownership of the New Market Community Center. Since then, we also graciously accepted the gift from the American Legion of their property. There is also the new water tank and infrastructure improvement projects that need to be discussed. We just received word from VDOT that they are moving our 211-sidewalk project up from 2025 to 2023. Additionally there is the remodeling of the pool house bathrooms, Little League ballfield improvements, Rebel Park restroom upgrades, possible community development on Clicks Lane, identifying and prioritizing capital improvement projects for 2023-27, exploring available grants for the remodeling of the community center etc, etc.

The above-mentioned list is less than a third of what we will be trying to discuss during our work planning session. As I stated in previous letters, we are focused on expanding our community so that we can attract merchants and business opportunities to New Market. Much of what we are doing is laying the foundation for New Market's growth. It is not possible to inform you of all that is happening in my brief letter to you. For that reason, I encourage your questions and input. After all, I serve you and learn from your concerns. However, I do ask that your input is constructive for the improvement of our town.

### CONTACT INFORMATION UPDATE

The beginning of the year is a great time to make sure your information is up to date. Often times our staff will attempt to contact our customers via phone when an issue is suspected at a property. It is always best to have a phone number where you can be reached during the day in case an emergency situation arises. Without a phone number on file often times we have to shut off water service to a property until an issue can be resolved and town staff is unable to make the resident aware. This can cause issues when a resident arrives home and no longer has access to water service. Phone numbers will never be shared outside of the town office. # SHORT-TERM RENTALS INCLUDING AIRBNB

The Town of New Market has passed Ordinance No. 107 which amends certain provisions of the Town Code relating to Short-Term Rentals. Operators of short-term rentals must obtain a zoning permit, an annual business license, and collect and remit to the Town a 5% transient occupancy tax. ## HEAVY TRASH PICK-UP

The Town's Public Works Crews will be collecting heavy trash items from April 11th through April 15th, 2022. Please place all heavy trash curbside. Crews will not go onto private property to make collections. This service is provided to our residential customers only. Crews will pick up trash by item type during the week and will have all trash picked up by the end of the day on Friday, April 15th, 2022. Brush and limbs must be tied in bundles no longer than four feet in length. To ensure removal, all heavy trash should be placed curbside no later than Friday, April 15th, 2022 by 12:00 noon. Due to State laws governing the operation of the Shenandoah County Landfill, the Town is unable to remove old TVs, computers, tires, refrigerators, freezers, lead acid batteries, or hazardous materials such as pesticides, herbicides, paint, paint thinner, etc. For instruction on where to take the aforementioned items, you may call the Shenandoah County Landfill at 540-984-8573. #### BOARD OF ZONING APPEALS VACANCY

There are currently openings on the Town of New Market's Board of Zoning Appeals. The Board of Zoning Appeals is a five member board that is appointed by the Shenandoah County Circuit Court. The Board is tasked with hearing and deciding appeals from decisions made by the Zoning Administrator, and requests for the relaxing of the requirements of the Zoning Ordinance. All appeals presented to the Board are on a case by case basis and every request for a variance needs to meet standards set forth in the Zoning Ordinance and Code of Virginia. The Board has no set meeting schedule, rather meeting as needed. Interested applicants may obtain a Volunteer application by visiting the Town's website, www.newmarketvirginia.com, and clicking the Government tab and selecting the Volunteer page. Applications may also be picked up at the Town Office. Completed applications should be returned to the Town Planner at the Town Office during regular business hours.
