#### MAYOR'S CORNER

How do you like the new look for Congress Street? The fresh pavement and paint are a vast improvement from just a month ago. I want to extend my sincere appreciation to the businesses and residents that had to avoid parking on Congress while this paving took place. I realize that in addition to the parking inconvenience there was also the noise through the night while many tried to sleep. I also want to thank VDOT for completing this project, as well as last year's paving on John Sevier Road from Old Cross Road to beyond the post office.

As I have mentioned in past articles, we the town do not have control of our streets and sidewalks. This has always been the responsibility of VDOT. Hopefully, this is about to change due to the recent decision by our council. This past month we have given our Town Manager the authorization to proceed in requesting that New Market becomes responsible for our secondary streets. If we receive permission from the legislature, then we will receive funds directly from the state each year to improve our streets and sidewalks. The estimated amount will be approximately \$270,000.00/year. That is not an avalanche of funds but at least we can start to prioritize the roads and sidewalks that need to be repaired or replaced.

#### The primary streets, which include Congress Street and Route 211 (both East and West), will remain VDOT's responsibility. Your council and town management have been investigating this move for over a year. Our Public Works Director, Chief of Police, previous Town Manager (TM) and I traveled to Richmond last year to discuss this with the Commissioner of VDOT and his subordinates. Nathan Garrison, our present TM, has continued the research and has been in contact with other towns that have made this same decision, and none have regretted it.

The process isn't complete since we must wait for approval from the legislature. We hope to have their authorization before the start of the next fiscal year which is 7/1/2025. When that time comes our public works department will be eager to improve neglected areas of our roadways which are long overdue. This is just another "foundational step" that we are initiating to improve New Market's future.

#### **HEAVY TRASH PICK-UP 2024**

The Town's Public Works Crews will be collecting heavy trash items ONE LAST TIME THIS YEAR. This month, they will be out picking up your heavy trash items from Tuesday, Oct. 15th through Friday, Oct. 18th. Please place all heavy trash curbside. Crews will not go onto private property to make collections. This service is provided to our residential customers only. Crews will pick up trash by item type during the week and will have all trash picked up by the end of the day on Friday, Oct. 18th, 2024. Brush and limbs must be tied in bundles no longer than four feet in length. To ensure removal, all heavy trash should be placed curbside no later than 7:00 am on Friday, Oct. 18th, 2024. Due to State laws governing the operation of the Shenandoah County Landfill, the Town is unable to remove old TVs, computers, tires, or hazardous materials such as pesticides, herbicides, paint, paint thinner, etc. For instruction on where to take the aforementioned items, you may call the Shenandoah County Landfill at 540-984-8573. #### MAINTAIN ACCESS TO YOUR WATER METER

It is very important that customers maintain clear access to their water meters from the public right-of-way. Obstacles that may block the radio signals include building materials, foliage and metal objects located between the street and the meter pit.

All town water customers are responsible for the upkeep of the area between their meter pit and the street. Please assist us by trimming foliage and by clearing snow and ice from the lid of the meter pit. Landscaping or fencing should be kept at least 1-3 feet from the meter pit.

Maintain access to your water meter to assist us with:

Meter Reading

• Emergency shutoffs (for frozen pipes) when you are away from home or are unable to turn off the water yourself; and

• Emergency water meter maintenance

## **ONLINE PAYMENTS NOW AVAILABLE!**

The Town of New Market is now accepting online payments for those customers who prefer the convenience of paying electronically with their debit/credit card. There will be a small service fee associated with making payments online. The Town will not profit from this fee.

Other payment options available to customers at no charge include in person via cash, check, money order or debit/credit card; by mail; or by depositing payment in the drop box located to the right of the entrance to the Town Office. In addition, water/sewer/trash customers can make payment through automatic monthly deductions from their bank account. Forms are available on our website or at the Town Office. We are no longer able to take your payment over the phone by calling the office. To pay via phone, call Paystar directly at 540-744-3614. There will be a service fee for doing so, which again, The Town will not profit from.

For the month of August, our crews ran a total of 149 calls. Of those calls, 111 calls were for EMS services and 38 calls for Fire services, with 78 of those calls within the town limits.

Many citizens of the community have noticed that we have been having some renovations done. For the past 5 months, we have been renovating our building to better serve our community. We replaced the existing bunkrooms and remodeled them to accommodate more volunteers and career staff. We have replaced one engine bay to house our turn out gear.
