Sec. 22-41 of the New Market Town Code "Yard Sales, Garage Sales and Sidewalk Sales"

*Yard Sales, Garage Sales and Sidewalks Sales* means a sale of personal property, which has been used generally in the household of the vendors and has not been acquired for resale, conducted at the personal residence of one of the vendors. Civic organizations are exempt from the following regulations, except that they must also comply with Sec. 46-4.

1. All individuals conducting a yard sale, etc., will be required to obtain a permit from the Town Office prior to the sale.
2. In all residential districts, the following rules shall apply:
  - a. A household will be allowed only two yard sales, etc., annually. This service shall be free.
  - b. Each sale cannot exceed a 72-hour consecutive period.
3. In all commercial districts, the following rules will apply to sales:
  - a. A household will be allowed two free yard sales, etc., annually. If any additional sales are held, the householder must obtain an annual permit at a fee as set from time to time by the Town Council.
  - b. Each sale cannot exceed a 72-hour consecutive period every three months.
4. All signs associated with such sales shall be removed within 24-hours after the conclusion of the sale.

*\*During the weekend of the Route 11 Yard Crawl, the Town will not count participation in that event towards total allowable yard sales on an annual basis.*

Sec. 46-4 of the New Market Town Code stipulates that: **"It shall be unlawful for any person to stick, nail, paste, tack or otherwise attach any notice, sign, poster, card, advertisement or other matter of a similar nature..., to or upon any utility pole or structure for**

**supporting wire, cable or pipe, or to a tree on any street or sidewalk, or to any public property, including authorized street signs or traffic signs, of any description.”**
