Summers End Pup Pool Party Rules

1. NO HUMANS are allowed in the big pool with the dogs at any time. No sitting on the pool steps. Sitting on side of the pool with feet in the pool will be allowed.
2. Humans are NOT allowed to swim in the baby pool. ONLY ONE Owner/Handler is allowed to wade in pool ONLY to assist dog.
3. Registration is required to participate.
4. Pool Area is limited to 50 dogs at one time.
5. All Dogs in heat are not allowed to participate.
6. Dogs must be under voice control of owner at all times.
7. Dogs must be removed at the first sign of aggression.
8. Dogs must be leashed when entering and exiting the pool facility.
9. Dogs must be accompanied by owner that is 18 years of age or older.
10. All dogs must have current rabies vaccination. Proof must be provided, and this does not include tags. NO EXCEPTIONS!
11. Owner must clean up dog feces. Seal waste in the provided plastic bags before disposing in designated receptacles.
12. Dangerous dogs, puppies under 6 months, dogs with parasites or any aggressive, non-socialized dogs are not allowed to participate.

Release of Claims :

I, the undersigned, do agree to indemnify and hold harmless the Town of New Market, Pool Management, associated pool and maintenance employees and agents thereof, from any and all claims or liability, including attorney's fees and costs for any personal injury or other damage suffered as a result of participating in the Summer's End Pup Pool Party. I understand that the pet owner or handler is responsible for the action of their dog(s), compliance with the pool rules and accepts full responsibility for any incidents that may occur. I further understand that the owner or handler will also be required to provide a copy of the dog's immunization record prior to the commencement of activity. Safety is always our concern: If any safety rules are broken during the pool party, you will be asked to leave.
